Dear Chairwomen Roybal-Allard and Ranking Member Fleischmann:

Thank you for your continued support for the Federal Emergency Management Agency's (FEMA) Nonprofit Security Grant Program (NSGP). As you know, the NSGP provides needed funding to nonprofit organizations at high risk of a terrorist attack. As you draft the Fiscal Year 2021 (FY21) Homeland Security Appropriations Bill, we respectfully ask you to fund the Urban Area Security Initiative (UASI) Nonprofit Security Grant Program (NSGP) at \$240 million and \$120 million for the State Homeland Security Grant Program (SHSGP) NSGP.

The NSGP supports critical security investments, such as physical security enhancements, emergency preparedness planning, training and exercises, and enhanced engagement and collaboration between public and private community representatives as well as their state and local homeland security and emergency management government agencies. The Department of Homeland Security (DHS) has recommended these types of investments to secure these targets within the faith-and community-based sector because DHS recognizes their vulnerability to attack is elevated and nonprofit institutions often lack the needed resources to invest in protective measures.¹ In today's quickly evolving threat environment, these investments are needed more than ever.

In February, Federal Bureau of Investigation (FBI) Director Chris Wray testified before the House Judiciary Committee that the FBI has elevated its assessment of the threat posed by racially motivated violent extremists in the U.S. to a "national threat priority" this fiscal year.² In January, the FBI, DHS and National Counterterrorism Center issued two Joint Intelligence Bulletins outlining the escalating threats against faith-based and nonprofit communal organizations. In one, they assessed that Domestic Violent Extremists and Racially/Ethnically Motivated Violent Extremists would continue to pose a lethal threat to faith-based communities,

particularly the Jewish community.³ In the second, they assessed that if Iran were to perceive actions of the U.S. as acts of war or existential threats to the Iranian regime, Iran or its proxies, such as Hizballah, could commit attacks in retribution against U.S.-based Jewish individuals and interests.⁴ Both assessments warned that these threats would be difficult to detect in advance.

These assessments were based on multiple lethal incidents, violent attacks, and disrupted plots, including the mass casualty attacks against Jewish institutions in Pittsburgh (October 2018), Poway (April 2019), Jersey City (December 2019), and Monsey (December 2019). Over the course of the program, fewer than 33 percent of applications have been awarded. Between 2005 and 2019 FEMA received nearly 11,500 applications seeking approximately \$900 million in investments, but only 3,800 awards were made, funding just over \$300 million in investments.⁵ More than 7,500 applications seeking \$600 million in security enhancements were not funded. In today's threat environment, demand for NSGP resources is expected to grow substantially more, further widening the needs gap.

For these reasons, we respectfully urge you to strengthen funding for the NSGP by funding the UASI NSGP at \$240 million and \$120 million for the SHSGP NSGP. These funds are critical to preventing direct threats to communities and help protect at-risk nonprofit institutions from grave threats.
