## A BILL

To amend section 923 of title 18, United States Code, to require an electronic, searchable database of the importation, production, shipment, receipt, sale, or other disposition of firearms.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Crime Gun Tracing
- 5 Modernization Act of 2023".

## 1 SEC. 2. ELECTRONIC, SEARCHABLE DATABASES.

- 2 Section 923(g) of title 18, United States Code, is
- 3 amended by adding at the end the following:
- 4 "(8)(A) In this paragraph, the term 'foreign intel-
- 5 ligence information' has the meaning given the term in
- 6 section 101 of the Foreign Intelligence Surveillance Act
- 7 of 1978 (50 U.S.C. 1801).
- 8 "(B) Not later than 3 years after the date of enact-
- 9 ment of this paragraph, the National Tracing Center of
- 10 the Bureau of Alcohol, Tobacco, Firearms and Explosives
- 11 shall establish and maintain electronic, searchable data-
- 12 bases of all records within its possession of the importa-
- 13 tion, production, shipment, receipt, sale, or other disposi-
- 14 tion of firearms required to be submitted to the Bureau
- 15 of Alcohol, Tobacco, Firearms and Explosives by persons
- 16 licensed under this chapter.
- 17 "(C) Each licensee under this chapter may provide
- 18 the National Tracing Center with electronic access, con-
- 19 sistent with the requirements of this paragraph, to all
- 20 records within the licensee's possession that are required
- 21 to be kept under this chapter.
- 22 "(D) A licensee may voluntarily relinquish possession
- 23 of any non-electronic record required to be kept under this
- 24 chapter to the Bureau of Alcohol, Tobacco, Firearms and
- 25 Explosives if—

1	"(i) 10 years have elapsed from the date of the
2	firearm transaction; or
3	"(ii) in the case of paper acquisition and dis-
4	position books, 10 years have elapsed without any
5	open disposition entries and with no dispositions re-
6	corded in the record.
7	"(E) The National Tracing Center—
8	"(i) shall have remote access to and may query,
9	search, or otherwise access the electronic databases
10	described in this paragraph; and
11	"(ii) may, with the permission of a State, or po-
12	litical subdivision of a State, have remote access to,
13	and may query, search, or otherwise access the data-
14	bases of the firearms registration system or pawn-
15	broker records system of the State or political sub-
16	division.
17	"(F) The National Tracing Center may query,
18	search, or otherwise access the electronic databases de-
19	scribed in this paragraph for only the following purposes:
20	"(i) To obtain information related to a bona
21	fide law enforcement investigation by a Federal,
22	State, local, tribal, or foreign law enforcement agen-
23	ey.
24	"(ii) To obtain information that is—
25	"(I) foreign intelligence information; or

1	"(II) necessary to understand, or assess
2	the importance of, foreign intelligence informa-
3	tion.
4	"(iii) To obtain information necessary during a
5	compliance inspection of an active licensee who has
6	submitted non-electronic records in accordance with
7	subparagraph (D).
8	"(G) The databases established under this para-
9	graph—
10	"(i) shall be electronically searchable by date of
11	acquisition or disposition, license number, and the
12	information identified on each firearm or other fire-
13	arm descriptor, including the manufacturer, im-
14	porter, model, serial number, type, and caliber or
15	gauge;
16	"(ii) shall not be electronically searchable by
17	the personally identifiable information of any indi-
18	vidual; and
19	"(iii) shall include in search results the entire
20	contents of the relevant records kept by the licensee.
21	"(H) This paragraph shall take effect notwith-
22	standing any other provision of law, including any tem-
23	porary or permanent restrictions placed on funds made
24	available to the Bureau of Alcohol, Tobacco, Firearms and
25	Explosives, or the Department of Justice.".
